23-013

An Ordinance amending Chapter 33, Unified Development Ordinance, Articles 6, 8, and 15 of the Code of Ordinances of the City of Lee's Summit, Missouri to accommodate recent changes to the Missouri Constitution regarding medical marijuana and marijuana. (CEDC 1/11/23)

Brian Head, City Attorney, provided a brief overview of all the ordinances on the agenda and explained the changes being made due to the legalization of recreational marijuana.

The ordinances address the following changes/updates:

- 1. Unified Development Ordinance (UDO) changes so recreational marijuana has the same restrictions as medical marijuana.
- 2. Clean Indoor Air Act amendments to prohibit marijuana in the same places tobacco and vaping are prohibited.
- 3. Business license updates to include all marijuana businesses.
- 4. Incorporate limitations on punishments in the City code.
- 5. Defines the types of marijuana offenses.

Josh Johnson, Director of Development Services, identified the revisions needed in the UDO include updates to the:

- 1. Conditional uses
- 2. Business License (as explained above)/buffers
- 3. Use Table
- 4. Definitions

Staff answered questions from the Committee members.
