## **BILL NO. 25-214**

AN ORDINANCE AUTHORIZING THE CITY MANAGER TO EXECUTE A CONTRACT WITH KANSAS CITY AUDIO-VISUAL FOR A MULTI-DEPARTMENT AUDIO-VISUAL SYSTEM PROJECT IN A NOT TO EXCEED AMOUNT OF \$651,347 TO PROVIDE THE PURCHASE OF AUDIO-VISUAL EQUIPMENT, INSTALLATION, MAINTENANCE AND SUPPORT FOR VARIOUS CONFERENCE ROOMS FOR THE CITY OF LEE'S SUMMIT, MISSOURI.

WHEREAS, through the Procurement and Contract Services Division RFP was issued to select a Multi Department Audio Visual solutions to manage the City's Audio Visual needs; and,

WHEREAS, eight responses were received in response to RFP. A selection committee consisting of staff from ITS, Police, Water and Finance evaluated each of the proposals. The Committee selected KCAV as the best solution to meet the City's needs. KCAV will facilitate the design, implementation and training of the solution and,

WHEREAS, the City desires to enter into a agreement with KCAV to provide the Audio Visual solution through standardized equipment and professional services and brings forth the agreement for approval.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT, MISSOURI, as follows:

SECTION 1. The contract which is attached hereto as Exhibit A and incorporated herein by reference (the "Agreement"), is hereby approved in a not to exceed amount of \$651,347 and the City Manager is authorized to execute the Agreement in substantial compliance with the attached version. The City Council hereby delegates authority to City staff to negotiate such changes to the Agreement and its exhibits as are necessary to complete the Agreement and carry out the purposes and intent of the Project for the City. Such changes may include changes to the Agreement, provided that the price paid for the services and the other items which constitute the consideration do not change.

SECTION 2. This Ordinance shall be in full force and effect from and after the date of its passage and adoption, and approval by the Mayor.

SECTION 3. Should any section, sentence, or clause of this Ordinance be declared invalid or unconstitutional, such declaration shall not affect the validity of the remaining sections, sentences, or clauses.
