B. 2024-6425 Continued discussion: Televising of Boards and Commissions

The Committee discussed broadcasting and recording City meetings.

After general discussion regarding:

1. logistics - moving meetings to rooms with AV equipment
2. volunteers not wanting to be on camera or have any side conversations recorded (more informal settings)
3. How to handle meetings where the group goes on a tour
4. Which meetings should be broadcast live, recorded with camera and voice and uploaded, recorded with just voices, camera and audio with broad view of the room (not focusing on individuals).
5. Some meetings where taxes and water rates are discussed
6. If subcommittees should be recorded
7. importance of transparency
8. Having some disclaimer language if a group was taking a tour or their was a video malfunction. "meetings will be recorded where reasonably practicable"
9. Having a definition for Task Force and Ad Hoc meetings

The Committee discussed several different boards and commissions and asked staff several questions about the practicability of recording some of the boards and commissions. Ultimately the Committee concluded that City Council, City Council Committees, Planning Commission and the Tax Increment Finance Commission should be broadcast live and recorded for availability on the City website and other platforms. The Parks and Recreation Board should be recorded and posted but that it was not required to be broadcast live. Other Boards and Commissions such as: Board of Aeronautic Commissioners, Human Relations Commission, License Tax Review Committee, the Public Safety Advisory Board, Water Utilities Board, Board of Appeals, Wellness Commission, Cultural Commission, Land Clearance for Redevelopment Authority and the Board of Zoning Adjustments should be recorded and posted when practicable but that it was not necessary to broadcast live.

Mr. Head indicated that he would draft a resolution incorporating these "buckets" of broadcast, recording and publication for the next meeting.

Chairperson Shields requested a definition of "ad hoc" be included in the resolution.

Christal Weber asked about the applicability to subcommittees. Discussion

followed with the consensus of the Committee being that these requirements wouldn't apply to subcommittees.

6. Roundtable

Councilmember Hodges inquired regarding the Succession Plan for if/when Mayor and Mayor Pro Tempore are unavailable that the Committee worked on at a previous meeting.

Brian Head mentioned that he is working on finalizing the document.

Councilmember Shields proactively requested that Staff prepare a formal presentation of the Charter Review Commission Process and place it on a future agenda for discussion.

The next scheduled City Council Rules Committee meeting is scheduled Dec. 19, 2024.
