AN ORDINANCE APPROVING CHANGE ORDER NO. 1 TO THE ON-CALL AGREEMENT 2024-057/2R FOR THE CONSTRUCTION OF SE 5TH ST STORM REPAIR – WO131527 WITH WIEDENMANN, INC. FOR AN INCREASE IN THE CONTRACT PRICE OF \$128,577.99, FOR A REVISED AGREEMENT AMOUNT OF \$469,928.99 AND AUTHORIZING THE CITY MANAGER TO EXECUTE AN AGREEMENT FOR THE SAME.

WHEREAS, through Ordinance 9567 and LS Bid #2024-057/2R, the City and Wiedenmann, Inc. (“Contractor”) entered into an Agreement for Wastewater Sewer System Infrastructure Repairs to remove and replace failing corrugated metal pipe (CMP) at SE 5th St between SE Onyx and SE Topaz Dr.; and,

WHEREAS, in accordance with Section 4.3 of the Agreement, Wiedenmann, Inc. submitted an estimated construction cost of \$341,251.00 to perform the work; and,

WHEREAS, due to unexpected work required to complete the project, the City and Contractor desire to increase the agreement price to include costs that became apparent during construction.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT, MISSOURI, as follows:

SECTION 1. The City Council of the City of Lee's Summit, Missouri, hereby approves Change Order No. 1 for construction of SE 5th St Storm Repair – WO131527 for a revised agreement amount of \$469,928.99.

SECTION 2. The change order between the City of Lee's Summit, Missouri, and the Contractor, attached hereto as Change Order 1 and incorporated by reference, is hereby approved, and the City Manager, or designee, is hereby authorized to execute the same, substantially similar on behalf of the City of Lee's Summit, Missouri.

SECTION 3. The City Manager, or designee, is further authorized to take such further action and execute such documents as may be necessary or desirable to carry out and comply with the intent of this Ordinance.

SECTION 4. This Ordinance shall be in full force and effect from and after the date of its passage and adoption, and approval by the Mayor.

SECTION 5. Should any section, sentence, or clause of this Ordinance be declared invalid or unconstitutional, such declaration shall not affect the validity of the remaining sections, sentences, or clauses.
