B. 2024-6104 Discussion: Legislative Updates

Brian introduced Zach Pollock (City's Lobbyist) and John Hensley (Partner) from VERSA Governmental Strategies.

Mr. Pollock and Mr. Hensley gave the Committee a legislative update regarding bills being proposed that may have an impact, if approved, on Municipalities (i.e. landfill, candidate filings, paint recycling, etc.).

After the update, Mr. Pollock and Mr. Hensley left the meeting at 12:05 p.m.

C. 2024-6116 Discussion: Paint Recycling program legislation

Chris Bussen, Solid Waste Superintendent for the Public Works Department gave a presentation from Mid America Regional Council(MARC) titled "Paint Management in Missouri".

The presentation pointed out the issues and statistics of unused paint and potential legislation that would help if passed. Chris mentioned the Solid Waste Management District in Missouri is supporting legislation that would provide an opportunity to replace taxpayer money that goes into recycling paint programs with a user fee for people that use paint.

He also explained to the Committee how this initiative would work and be managed by a representative organization (Paint Care) and how this legislation would positively effect Missouri citizens.

He explained the biggest benefit of this program would be having more places available for citizens to drop off paint to retailers, that would be more convenient, be open longer hours, and closer to home. If unused paint is more convenient to drop off, it would be less likely to end up in the trash and disposed of inappropriately and dangerously.

Consensus of the Committee was to have our lobbyist work to support this bill.
