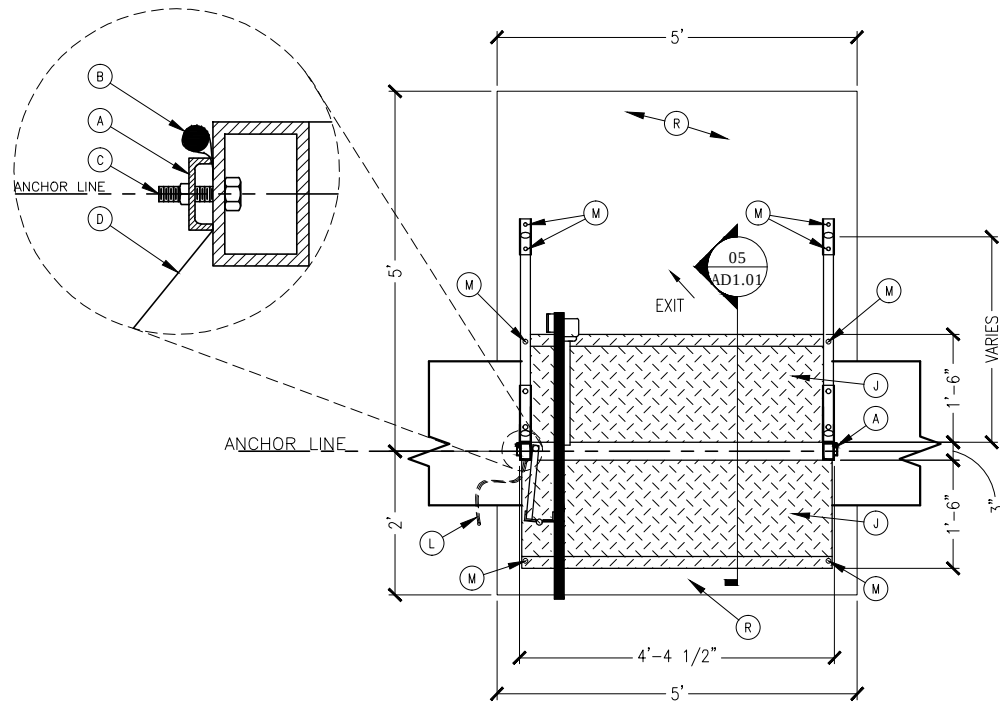


02 DOME PROFILE HEIGHTS

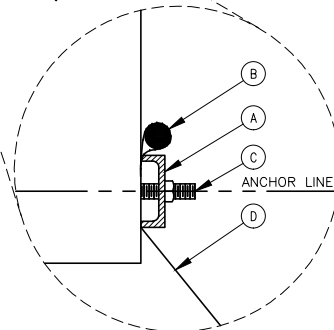

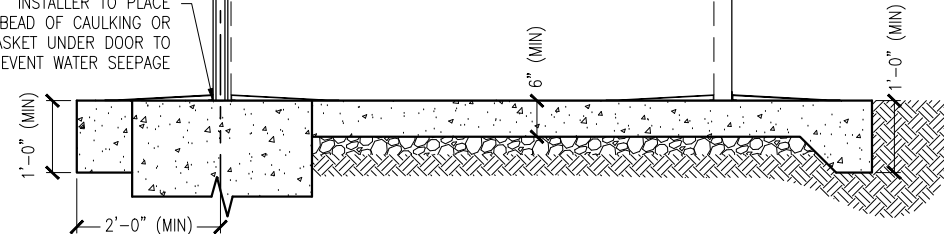

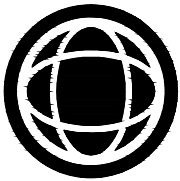

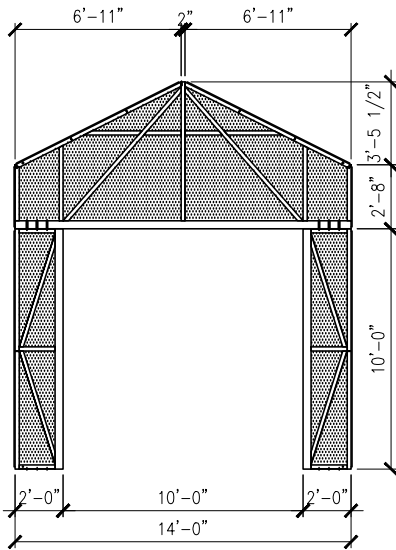

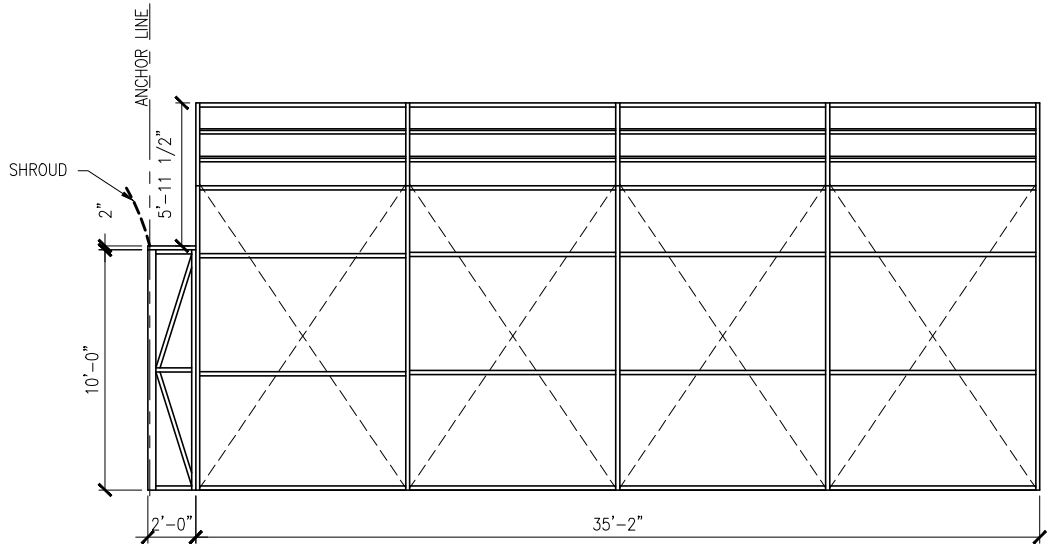
04 INTERIOR FRAME ASSEMBLY
