AN ORDINANCE APPROVING A SOLE SOURCE AGREEMENT FOR PROFESSIONAL ENGINEERING SERVICES FOR THE EAST FORK OF LITTLE BLUE WATERSHED STORMWATER IMPROVEMENT PROJECT BY AND BETWEEN THE CITY OF LEE'S SUMMIT, MISSOURI, AND ALLGEIER, MARTIN & ASSOCIATES, FOR AN AMOUNT NOT TO EXCEED \$158,000.00, AND AUTHORIZING THE CITY MANAGER TO EXECUTE AN AGREEMENT FOR THE SAME.

WHEREAS, City staff identified locations within the City where structural flooding occurs; and,

WHEREAS, pursuant to Ordinance No. 8091, the City and Allgeier, Martin & Associates (hereinafter "Engineer") entered into an Agreement for Professional Engineering Services for SE 5th Terrace Roadway Stream Crossing and FEMA Map Revisions (RFQ No. 2017-305-C) in accordance with state statutes and local policies; and

WHEREAS, Public Works Engineering staff recommends contracting with the Engineer to design the East Fork of Little Blue Watershed Stormwater Improvement Project; and,

WHEREAS, under the City's Procurement Policy, as approved under Ordinance No. 8758, the requirement of competitive bids may be waived when "a firm has significant previous or specialized knowledge on a proposed project that would result in significant and/or time savings in completion of the project"; and,

WHEREAS, Engineer has expertise and knowledge of approximately 4,500 feet of the East Fork of Little Blue upstream to Winburn Trail from the completion of work performed under RFQ#2017-305; and

WHEREAS, the City and Engineer both desire to enter into a Sole Source Agreement for Professional Engineering Services for the East Fork of Little Blue Stormwater Project (hereinafter "Agreement"); and

WHEREAS, funding for this project is authorized from the CIP Sales Tax Renewal Fund that was approved by voters in April 2017 and became effective on April 1, 2018.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT, MISSOURI, as follows:

SECTION 1. That the City Council of the City of Lee's Summit, Missouri hereby approves the Agreement between the City of Lee's Summit and Allgeier, Martin & Associates, for Professional Engineering Services for the East Fork of Little Blue Stormwater Project, for an amount not to exceed \$158,000.00, as attached hereto as "Exhibit 1" and incorporated herein by reference, and the City Manager is hereby authorized to execute the same.

SECTION 2. That this Ordinance shall be in full force and effect from and after the date of its passage and adoption, and approval by the Mayor.
