9. Committee Reports

Councilmember Prier provided a brief recap of the items considered by the Public Works Committee yesterday including 3 grant agreements that were approved tonight.

Councilmember Hodges advised the Community and Economic Development Committee met last week and discussed updating the panhandling ordinance. She noted they will be discussing these topics next month: Public intoxication & prowler Ordinances and some changes that will be made for the World Cup.

Councilmember Carlyle provided information on the Legislative and Intergovernmental Relations Committee that met yesterday which include the report by the City's lobbyist that was heard tonight. They will continue discussing the possibility of obtaining a federal lobbyist and that will come back with more information on cost.

She expressed that the developer being criticized has completed many successful projects and has been an active and valued member of the Lee's Summit community.

He noted that informational meetings will be held by district to discuss trash hauling, and additional details about these meetings will be shared soon.
