AN ORDINANCE APPROVING THE CALENDAR YEAR 2025 EMPLOYEE BENEFIT PROGRAMS; APPROVING AGREEMENTS FOR SERVICES BY AND BETWEEN THE CITY OF LEE'S SUMMIT, MISSOURI AND CIGNA HEALTH AND LIFE INSURANCE COMPANY, METROPOLITAN LIFE INSURANCE COMPANY, HARTFORD LIFE AND ACCIDENT INSURANCE COMPANY, CURALINC, LLC, NAVIA BENEFIT SOLUTIONS, INC., AND TRUSTMARK INSURANCE COMPANY, AND AUTHORIZING THE CITY MANAGER TO EXECUTE AGREEMENTS AND OTHER DOCUMENTS AS NECESSARY TO ADMINISTER EMPLOYEE BENEFITS FOR CALENDAR YEAR 2025 ON BEHALF OF THE CITY.

WHEREAS, the City of Lee's Summit ("City") enters into agreements with various companies to provide employee benefits including health, dental, vision, and life insurance, as well as employee assistance services; and,

WHEREAS, the City has existing contracts that with Cigna Health and Life Insurance Company, Metropolitan Life Insurance Company, Hartford Life and Accident Insurance Company, CuraLinc, LLC, Navia Benefit Solutions, Inc., and Trustmark Insurance Company that allow for renewals; and,

WHEREAS, the City and the aforementioned entities desire to formalize the renewals described herein and further, to the extent necessary, and to enter into formal agreements delineating the terms and conditions related to the provision of services as summarized herein.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT, MISSOURI, AS FOLLOWS:

SECTION 1. The calendar year 2025 employee benefit programs for the City of Lee's Summit to provide medical and dental insurance coverage; vision insurance coverage; life and accidental death and disability insurance coverage; employee assistance services; and voluntary benefits is approved, and the provision of such coverages and services by Cigna Health and Life Insurance Company, Metropolitan Life Insurance Company, Hartford Life and Accident Insurance Company, CuraLinc, LLC, Navia Benefit Solutions, Inc., and Trustmark Insurance Company as set out in Exhibit "A" attached are approved.

SECTION 2. The City Manager is authorized to execute any and all documents necessary to ensure the implementation and continuation of these programs under the same or substantially similar terms and conditions.

SECTION 3. This Ordinance shall be in full force and effect from and after the date of its adoption, passage, and approval by the Mayor.

SECTION 4. Should any section, sentence, or clause of this Ordinance be declared invalid or unconstitutional, such declaration shall not affect the validity of the remaining sections, sentences or clauses.
