- Average increase last year (2022-2023) 22.63%
- New Construction decreased - working with Jackson County at this time
- Numbers sent on Wednesday and then Jackson County updated on Thursday - with change in numbers - not a reassessment year (will reassess next year)
- What increase is CPI - 3.4% - City cannot increase at all
- Levy will remain the same - no option to increase revenue
- Levy goes up due to decrease in assessed valuation
- Raise levy a small amount so City does not lose money
- What happens in other cities in Missouri
- Raise levy .66%
