AN ORDINANCE AUTHORIZING THE EXECUTION OF A MEMORANDUM OF UNDERSTANDING BY AND BETWEEN THE CITY OF LEE'S SUMMIT, MISSOURI AND THE LEE'S SUMMIT R-7 SCHOOL DISTRICT FOR THE IMPACT PROGRAM.

WHEREAS, the City of Lee's Summit, Missouri ("City") received a grant from the Jackson County COMBAT Drug Commission ("COMBAT grant") to assist in defraying the cost of the City's IMPACT program; and,

WHEREAS, IMPACT is an anti-drug and stress management curriculum built around a current and ever-changing culture that teaches students to make smart and healthy decisions using the core values of integrity, responsibility, respect, and prevention; and,

WHEREAS, via the COMBAT grant and City funding, the City provides law enforcement officers who provide IMPACT education in the Lee's Summit R-7 School District's ("District") elementary and middle schools ("IMPACT operators"); and,

WHEREAS, the IMPACT program benefits District students in the 5<sup>th</sup> grade and 7<sup>th</sup> grade by providing education to resist the use of tobacco, alcohol, marijuana, and vaping, as well as, providing an understanding of the skills to manage stress, resist peer pressure, and control emotions during conflicts; and,

WHEREAS, the Parties desire to define their relationship and duties regarding continuation of the IMPACT program for 5<sup>th</sup> and 7<sup>th</sup> grade students at District schools.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT, MISSOURI, as follows:

SECTION 1. That the City Council of the City of Lee's Summit hereby approves and authorizes the execution, by the Mayor, of a memorandum of understanding by and between the City of Lee's Summit, Missouri and the Lee's Summit R-7 School District for the IMPACT program, which is attached hereto and incorporated by reference as if fully set forth herein.

SECTION 2. That this Ordinance shall be in full force and effect from and after the date of its passage and adoption, and approval by the Mayor.
