4. Public Comments

I try to help the city, by frequently reporting signs that I believe to be violating city codes. But what happens is illustrated by today's experience.

I reported a sign in the right of way at 10:00 AM. At 10:28 AM, I received a reply" "Code Violations (16201204) was closed by Sarah

Thank you for submitting this concern. A Neighborhood Services Officer will perform an inspection within five business days to determine if a violation exists. Please see Article 9 in the Unified Development Ordinance at www.cityofls.net for more information regarding City sign regulations." That's the end of the case, unless I choose to try calling next week to find out the status, etc.

There are probably times when I report a situation that does not actually violate city codes. But I don't know that, and continue to report similar cases, thus wasting city resources (and mine).

Of more importance, the lack of feedback undoubtedly tends to discourage citizens from continuing to make the effort to report problems.

I understand that it takes more effort, but a simple "We removed it" or "We looked and it was no longer there" or "Allowable uncer code ###" would, I believe, be a better service to citizens, and would encourage more reporting.

Public Hearing: Community Development Block Grant Annual Action Plan for Program Year 2024-25

Sarah Tilbury, CDBG Administrator, presented an overview of the 2024-25 CDBG Annual Action Plan, timeline, funding caps and prioritization process. HUD had not announced the amount of funding this year so staff is basing the funding amount on last year's allocation of \$354,909.

A representative from each of the following organizations presented information about their funding requests and staff shared their recommendations of the requests followed by discussion.

After discussion, the CEDC approved staff's recommendations as indicated below:

While the LS Housing Authority requested funding, because their previous HUD allocation funding has not been finalized as to date, staff recommend not funding their requests to allow them time to get caught up so as not to jeopardize future HUD funding allocations to the City of Lee's Summit based on timeline of completed projects.
