

## **BILL NO. 25-130**

AN ORDINANCE AUTHORIZING THE CITY MANAGER TO EXECUTE A SERVICE AGREEMENT WITH INFOTECH RESEARCH GROUP IN AN ANTICIPATED AMOUNT OF \$106,805.61 TO BE SPENT BETWEEN NOW AND JULY 2026 TO ENABLE THE CITY TO OBTAIN A GUIDED WORKSHOP TRAINING AND ANNUAL SUBSCRIPTION FOR PROFESSIONAL SERVICES RELATED TO DATA GOVERNANCE AND TECHNICAL CONTRACTS, AND FURTHER AUTHORIZING THE CITY MANAGER TO EXECUTE ANY SUBSEQUENT DOCUMENTS NECESSARY TO OBTAINED THE SAME SERVICES FOR FY27 IN THE SAME AMOUNT SUBJECT TO THE FY27 BUDGET.

WHEREAS, the City of Lee's Summit, Missouri is a constitutional charter City, organized and existing under the laws of the State of Missouri (hereinafter "City"); and,

WHEREAS, the City currently maintains infotech research group provides the city with necessary and detailed consultation and training in data governance and technical contracts; and,

WHEREAS, the City Council desires to convey authority the City Manager the ability to continue contracts with infotech research group without the necessity of additional approvals by the council; and,

WHEREAS, the City Council must approve spending in excess of \$75,000 per contract, and spending for both of these contract years will exceed that amount.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT, MISSOURI, AS FOLLOWS:

SECTION 1. The City Manager is hereby authorized to execute the Service Agreement with Infotech Research Group, Attachment A to this ordinance and all other necessary documents necessary to access these services in the anticipated amount of \$106,805.61 for FY26 and renewal in the anticipated amount of \$106,805.61 for FY27 subject to provision of funds in the annual budgets.

SECTION 2. This Ordinance shall be in full force and effect from and after the date of its passage and adoption, and approval by the Mayor.

SECTION 3. Should any section, sentence, or clause of this Ordinance be declared invalid or unconstitutional, such declaration shall not affect the validity of the remaining sections, sentences or clauses.
