AN ORDINANCE AUTHORIZING THE CITY MANAGER TO PURCHASE HARDWARE, SOFTWARE AND SERVICES THROUGH THE STATE OF MISSOURI COOPERATIVE PURCHASING AGREEMENT WITH SHI INTERNATIONAL FOR A NOT TO EXCEED AMOUNT OF \$1,150,000 AS SET OUT IN THE FY26 BUDGETAND AUTHORIZING THE CITY MANAGER TO EXECUTE ANY SUBSEQUENT DOCUMENTS NECESSARY TO OBTAIN THE SAME FOR THE TERM OF THE AGREEMENT FOR THE CITY OF LEE'S SUMMIT, MISSOURI.

WHEREAS, the City of Lee's Summit, Missouri is a constitutional charter City, organized and existing under the laws of the State of Missouri (hereinafter "City"); and,

WHEREAS, the City has entered into a Cooperative Purchasing Agreement through the State of Missouri with SHI International for computer hardware, software and services, which agreement is attached hereto as Exhibit "A".

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT, MISSOURI, as follows:

SECTION 1. The City Manager is authorized to purchase hardware, software and services through the State of Missouri Cooperative Purchasing Agreement with SHI International for a not to exceed amount of \$1,150,000 as set out in the FY26 budget and to execute any subsequent documents necessary to obtain the same for the term of the agreement. The City Council hereby delegates authority to City staff to negotiate such changes to the Agreement, attached as "Exhibit A" and its exhibits as are necessary to complete the Agreement and carry out the purposes and intent of the Project for the City. Such changes may include changes to the Agreement, provided that the price paid for the services and the other items which constitute the consideration do not change.

SECTION 2. This Ordinance shall be in full force and effect from and after the date of its passage and adoption, and approval by the Mayor.

SECTION 3. Should any section, sentence, or clause of this Ordinance be declared invalid or unconstitutional, such declaration shall not affect the validity of the remaining sections, sentences, or clauses.
