

## **BILL NO. 25-071**

AN ORDINANCE APPROVING THE AWARD OF RFP NO. 2025-036 FOR FINANCIAL AUDITING SERVICES FOR A ONE-YEAR TERM WITH UP TO FOUR, ONE-YEAR RENEWALS, TO FORVIS MAZARS, LLP, AND AUTHORIZING THE CITY MANAGER TO EXECUTE THE SAME BY AND ON BEHALF OF THE CITY OF LEE'S SUMMIT, MISSOURI.

WHEREAS, the City of Lee's Summit, Missouri is required to perform a financial audit annually; and,

WHEREAS, the Procurement and Contract Services department issued RFP No. 2025-036 for Auditing Services via its e-bidding service, Public Purchase, inviting interested firms to participate; and,

WHEREAS, of the proposals received, FORVIS MAZARS, LLP was the top ranked firm by the evaluation committee.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT, MISSOURI, as follows:

SECTION 1. The City Council of the City of Lee's Summit, Missouri hereby authorizes the award of RFP No. 2025-036 to FORVIS MAZARS, LLP.

SECTION 2. The agreement by and between the City of Lee's Summit and FORVIS MAZARS, LLP for audit services for an initial term of one-year, with up to four, one-year renewals in an amount not to exceed \$130,321.00 for the first year with yearly increases up to \$149,372.00 in the fifth year of the contract, which contract is attached as Exhibit A the FORVIS MAZARS LLP Engagement Letter and incorporated herein by reference, is hereby approved, and the City Manager is authorized to execute the same and any related documents necessary to carry out the agreement by and on behalf of the City.

SECTION 3. This Ordinance shall be in full force and effect from and after the date of its passage and adoption, and approval by the Mayor.

SECTION 4. Should any section, sentence, or clause of this Ordinance be declared invalid or unconstitutional, such declaration shall not affect the validity of the remaining sections, sentences, or clauses.
