

## **BILL NO. 24-201**

AN ORDINANCE APPROVING THE USE OF A COOPERATIVE CONTRACT BETWEEN THE CITY OF INDEPENDENCE, MISSOURI AND BAYSINGER'S UNIFORMS AND EQUIPMENT TO PURCHASE BALLISTIC VESTS AND THE ASSOCIATED ACCESSORIES FOR THE LEE'S SUMMIT POLICE DEPARTMENT'S EMERGENCY SERVICES SQUAD IN THE AMOUNT OF \$107,936.14 AND AUTHORIZING THE CITY MANAGER TO EXECUTE ALL NECESSARY DOCUMENTS ON BEHALF OF THE CITY.

WHEREAS, the specialty ballistic vests utilized by members of the Police Department's Emergency Services Squad have reached the end of the manufacturer's recommended five (5) year lifespan and the City of Lee's Summit (the "City") has a need to purchase replacement vests; and,

WHEREAS, Section 6.1 of the City's Procurement Policy allows the City to make purchases from contracts that were originally procured by another entity, who has extended the pricing and terms of such contract to other entities such as the City; and,

WHEREAS, the City is able to procure law enforcement ballistic vests pursuant to a contract between the City of Independence, Missouri and Baysinger's Uniform and Equipment; and,

WHEREAS, the Police Department, and the City Manager seek approval from the City Council to use an existing Cooperative Contract with Baysinger's Uniforms and Equipment for the purchase of new ballistic vests, and that expenditure exceeds \$75,000; and,

WHEREAS, funding has been identified for the purchase of the ballistic vests in the City Council approved PSERP FY25 Budget, and the adopted FY25 Budget includes funds to cover remaining cost overruns that exceed the Police PSERP replacement balance; and,

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT, MISSOURI, as follows:

SECTION 1. The City Council of the City of Lee's Summit, Missouri hereby approves the City's use of the City of Independence's law enforcement equipment contract with Baysinger's Uniforms and Equipment (referred to as Cooperative Contract #2024-036), attached as Exhibit A, and incorporated herein by reference, and authorizes the City Manager to use the Cooperative Contract to purchase ballistic vests in the amount of \$107,936.14.

SECTION 2. The City Manager, or designee, is further authorized to take such further action and execute such documents as may be necessary or desirable to carry out and comply with the intent of this Ordinance.

SECTION 3. This Ordinance shall be in full force and effect from and after the date of its passage and adoption, and approval by the Mayor.

SECTION 4. Should any section, sentence, or clause of this Ordinance be declared invalid or unconstitutional, such declaration shall not affect the validity of the remaining sections, sentences, or clauses.
