AN ORDINANCE AWARDING THE BID FOR PROJECT NO. 1004 FOR THE I-470 BORE – ST. LUKE’S TO COLBERN ROAD PROJECT TO REDFORD CONSTRUCTION, INC. IN THE AMOUNT OF \$795,070.00, AND AUTHORIZING THE CITY MANAGER TO EXECUTE AN AGREEMENT FOR THE SAME.

WHEREAS, this Project will eliminate two pump stations, one publicly owned and one privately owned, by installing a gravity sewer main; and,

WHEREAS, the gravity sewer will be installed from the Douglas Pump Station to north of I-470 and consists of approximately 450 linear feet of 12 inch diameter pipe, including a jack-and-bore 24 inch casing pipe under I-470; and,

WHEREAS, I-470 Bore – St. Luke’s to Colber Road Project (“Project”) is funded by the Sewer Construction Fund and the American Rescue Plan Act (ARPA) Wastewater Legislative Priority grant funds; and,

WHEREAS, Water Utilities issued a bid for Project No. 1004 on August 26, 2024, in accordance with local policies and state statutes, and opened bids on September 25, 2024; and,

WHEREAS, Redford Construction, Inc. (“Contractor”) was determined to be the lowest and most responsible and responsive bidder by City staff; and,

WHEREAS, the City and Contractor desire to enter into an agreement for the Project.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE’S SUMMIT, MISSOURI, as follows:

SECTION 1. The City Council of the City of Lee’s Summit, Missouri, hereby awards the bid for the Project to the Contractor in the amount of \$795,070.00.

SECTION 2. The agreement between the City of Lee’s Summit, Missouri, and the Contractor, attached hereto as Exhibit A and incorporated by reference, is hereby approved, and the City Manager, or designee, is hereby authorized to execute an agreement substantially similar to the same on behalf of the City of Lee’s Summit, Missouri.

SECTION 3. The City Manager, or designee, is further authorized to take such further action and execute such documents as may be necessary or desirable to carry out and comply with the intent of this Ordinance.

SECTION 4. This Ordinance shall be in full force and effect from and after the date of its passage and adoption, and approval by the Mayor.

SECTION 5. Should any section, sentence, or clause of this Ordinance be declared invalid or unconstitutional, such declaration shall not affect the validity of the remaining sections, sentences, or clauses.
