AN ORDINANCE REPEALING ORDINANCE NO. 9727 AND APPROVING THE AWARD OF RFP 2023-050 FOR EMERGENCY DISPATCH SOFTWARE IN THE AMOUNT OF \$179,557.00 TO MEDICAL PRIORITY CONSULTANTS INC., dba PRIORITY DISPATCH CORP. AND RATIFYING THE CITY MANAGER’S EXECUTION OF THE SAME FOR ALL RELATED AND NECESSARY DOCUMENTS.

WHEREAS, the current Emergency Medical Dispatch process used by Fire Department is obsolete and need to be replaced; and,

WHEREAS, City staff issued RFP No. 2023-050 seeking qualified firms to provide Emergency Fire and EMS Dispatch software”); and,

WHEREAS, after review of those submissions received for RFP No. 2023-050, Medical Priority Consultants Inc, dba Priority Dispatch Corp, was the sole respondent and was deemed qualified to provide the software; and,

WHEREAS, the City desires to enter into an agreement with Medical Priority Consultants Inc, dba Priority Dispatch Corp; and,

WHEREAS, Ordinance No. 9727 was approved and adopted by the Council but was not in perfected form leading to it’s repeal and replacement,

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT, MISSOURI, as follows:

SECTION 1. The City Council of the City of Lee’s Summit, Missouri, hereby repeals Ordinance No. 9727 and approves the award of RFP No. 2023-050 to Medical Priority Consultants Inc, dba Priority Dispatch Corp the Architect for an amount of \$179,557.00.

SECTION 2. The City Council hereby approves and authorizes the City Manager, by and on behalf of the City of Lee’s Summit, Missouri, to execute an Agreement for Emergency Dispatch software attached as Exhibit 1.

SECTION 3. This Ordinance shall be in full force and effect from and after the date of its passage and adoption, and approval by the Mayor.

SECTION 4. Should any section, sentence, or clause of this Ordinance be declared invalid or unconstitutional, such declaration shall not affect the validity of the remaining sections, sentences, or clauses.
