AN ORDINANCE APPROVING THE AWARD OF RFP NO. 2024-028 FOR A YEARLY AGREEMENT WITH FOUR POSSIBLE ONE-YEAR RENEWALS FOR AVIATION FUEL SERVICES FOR LEE'S SUMMIT MUNICIPAL AIRPORT TO AVFUEL CORPORATION AND AUTHORIZING THE CITY MANAGER TO EXECUTE AN AGREEMENT FOR THE SAME.

WHEREAS, the Aviation Fuel Service Program is a key element for the revenues of the Aviation Division; and,

WHEREAS, the FY2024 Aviation Fuel Service Program will provide for the purchase and resale of approximately 385,000 gallons of Jet-A and 100LL Fuel, the rental of three mobile re-fuelers, and,

WHEREAS, aviation fuel services is a specialized service, which is performed by contractors that perform this service; and,

WHEREAS, the City issued RFP No. 2024-028 for the FY24 Aviation Fuel Services Program; and,

WHEREAS, of the proposals received, AVFUEL Corporation, Inc. has been determined to be the highest ranking firm by the project evaluation committee.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT, MISSOURI, as follows:

SECTION 1. That the City Council of the City of Lee's Summit, Missouri hereby authorizes the award of RFP No. 2024-028 for a yearly agreement with four possible one-year renewals for aviation fuel services for the Aviation Division of Public Works to AVFUEL Corporation, Inc., substantially similar to said Agreement attached hereto as "Exhibit 1".

SECTION 2. The City Council of the City of Lee's Summit, Missouri, hereby authorizes the Mayor to execute the same on behalf of the City of Lee's Summit, Missouri.

SECTION 3. The Mayor is further authorized to take such further action and execute such documents as may be necessary or desirable to carry out and comply with the intent of this Ordinance.

SECTION 4. This Ordinance shall be in full force and effect from and after the date of its passage and adoption, and approval by the Mayor.

SECTION 5. Should any section, sentence, or clause of this Ordinance be declared invalid or unconstitutional, such declaration shall not affect the validity of the remaining sections, sentences, or clauses.
