

## **BILL NO. 24-111**

AN ORDINANCE AWARDING THE BID FOR PROJECT NO. 576-9C FOR THE EAST FORK LITTLE BLUE AREA 2 STORMWATER PROJECT TO INFRASTRUCTURE SOLUTIONS, LLC IN THE AMOUNT OF \$1,112,852.00, AND AUTHORIZING THE CITY MANAGER TO EXECUTE AN AGREEMENT FOR THE SAME.

WHEREAS, City staff identified locations in the City where structural flooding occurs, including including SE Country Lane and SE 6<sup>th</sup> Street; and,

WHEREAS, the stormwater improvements at SE Country Lane and SE 6<sup>th</sup> Street, designed by Allgeier Martin and Associates pursuant to Ordinance No. 9308, includes the installation of approximately 1,200 feet of new storm sewer pipe (“Project No. 576-9C”); and,

WHEREAS, Project No. 576-9C is funded through an ARPA Grant through the Missouri Department of Natural Resources (MDNR); and,

WHEREAS, Public Works Engineering issued an advertisement for bids for the construction of Project No. 576-9C on April 24, 2024, in accordance with local policies and state statutes; and,

WHEREAS, Infrastructure Solutions, LLC (“Contractor”) was evaluated to be the lowest and best bidder by City staff; and,

WHEREAS, the City desires to enter into an agreement with the Contractor to construct Project No. 576-9C.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT, MISSOURI, as follows:

SECTION 1. The City Council of the City of Lee's Summit, Missouri, hereby awards the bid for Project No. 576-9C to the Contractor in the amount of \$1,112,852.00.

SECTION 2. The agreement between the City of Lee's Summit, Missouri, and the Contractor, attached hereto as Exhibit A and incorporated by reference, is hereby approved, and the City Manager is hereby authorized to execute the same or substantially similar on behalf of the City of Lee's Summit, Missouri.

SECTION 3. This Ordinance shall be in full force and effect from and after the date of its passage and adoption, and approval by the Mayor.

SECTION 4. Should any section, sentence, or clause of this Ordinance be declared invalid or unconstitutional, such declaration shall not affect the validity of the remaining sections, sentences, or clauses.
