

BILL NO. 24-138

AN ORDINANCE APPROVING THE USE OF A COOPERATIVE CONTRACT BETWEEN OMNIA PARTNERS AND FORMS+SURFACES TO PURCHASE SITE FURNITURE AND FURNISHINGS AS NEEDED FOR CITY FACILITIES AND AUTHORIZING THE CITY MANAGER TO EXECUTE AND USE THE SAME BY AND ON BEHALF OF THE CITY OF LEE'S SUMMIT, MISSOURI.

WHEREAS, the City of Lee's Summit, Missouri (the "City") has a need to purchase site furniture and furnishings; and,

WHEREAS, Section 6.1 of the Procurement policy allows the City to make purchases from contracts that were originally procured by another entity but have extended the pricing and terms of such contract to other entities such as the City; and,

WHEREAS, the City is able to purchase site furniture and furnishings pursuant to a contract between Omnia Partners, a third-party aggregator that brings entities together, and Forms+Surfaces; and,

WHEREAS, Section 6.1 of the Procurement Policy requires a cooperative contract that has an estimated annual spend of \$50,000.00 or more be approved by City Council before it is used; and,

WHEREAS, the City anticipates spending over \$75,000.00 annually through the purchase of site furniture and furnishings.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT, MISSOURI, as follows:

SECTION 1. The City Council of the City of Lee's Summit, Missouri hereby approves the City's use of the Omnia Partners site furniture and furnishings contract with Forms+Surfaces Inc., (referred to as "Cooperative Purchasing Agreement between The City of Lee's Summit and Forms and Surfaces, Inc."), attached as Exhibit A and incorporated herein by reference, and authorizes the City Manager to execute and use the Cooperative Purchasing Agreement to purchase site furniture and furnishings from Forms + Surfaces.

SECTION 2. This Ordinance shall be in full force and effect from and after the date of its passage and adoption, and approval by the Mayor.

SECTION 3. Should any section, sentence, or clause of this Ordinance be declared invalid or unconstitutional, such declaration shall not affect the validity of the remaining sections, sentences, or clauses.
