Summary	Change Order 2
Change Order Description	There were many unforeseen items which were discovered once construction began. One item of note was the change in work for the Colbern road section of watermain. We decided to abandoned the 8" main and run new lines to connect into the 12" main. Another item which was very substantial was the missing 20" tees on Scherer road. There were several tees which were not called out on the plans. These were required in order to complete the construction of the new water line. Another item was the complete lack of locates for the Cedar Creek mall area. The lack of locates caused several days of exploratorily digging by the contractor. The contractor worked with One Call and Water Utilities during the

process. There were various other items which needed to be added to complete the project as planned. Along with existing line items which were overrun in order to complete the project.
