## 10. Council Comments:

Councilmember Shields would like to see a policy discussion in updating wording that creates a way to require and enforce compliance with our ordinances in order to get or keep receiving incentives. This matter will be referred to the Community and Economic Development Committee for further discussion.

Councilmember Prier would like the Council to have an "ask" at the legislative visit for support in the clean-up of trash along the highways and roadways that are maintained by MoDOT. Mayor Baird stated this would need to be vetted more by the Council before moving forward.

Councilmember Lovell stated the Public Works Committee considered some design concepts with a project that was approved through the no-tax-increase bond initiatives and wanted to know how they really go through making those decisions as a full council.

Mayor Baird stated he has met with the Lee's Summit Economic Development Council recently and they want to move forward with an ad-hoc committee with a past chair and begin working on the by-laws and the strategic plan with best practices to start moving forward with the City and a Public Service Agreement.
