AN ORDINANCE APPROVING THE AGREEMENTS FOR THE PURCHASE OF TREE TRIMMING AND REMOVAL SERVICES FROM CTC DISASTER RESPONSE, INC. AND SHAWNEE MISSION TREE SERVICE, INC. DBA ARBOR MASTERS AND AUTHORIZING THE CITY MANAGER TO EXECUTE AGREEMENTS FOR THE SAME.

WHEREAS, on April 30, 2023, the City entered into agreements with CTC Disaster Response, Inc. (Agreement 2023-049-1) and Shawnee Mission Tree Service, Inc. dba Arbor Masters (Agreement 2023-049-2) for Tree Trimming & Removal Services, at the time when annual tree trimming and removal service expenses were less than \$75,000 per year; and,

WHEREAS, the first of four yearly renewals was exercised February 2, 2024, with effective dates of April 30, 2024 through April 29, 2025; and,

WHEREAS, Public Works Department anticipates increased usage of these agreements for CIP projects which will exceed the \$75,000 maximum per year, per vendor; and,

WHEREAS, Section 4 of the Procurement policy states if the City anticipates spending more than \$75,000.00 in a year with a vendor, the City Council must approve the contract.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT, MISSOURI, as follows:

SECTION 1. The City Council of the City of Lee's Summit, Missouri, hereby approves the oncall agreement with CTC Disaster Response, Inc. to provide tree trimming and removal services, attached hereto as Exhibit A and incorporated by reference, and authorizes the City Manager to execute the same or substantially similar.

SECTION 2. The City Council of the City of Lee's Summit, Missouri, hereby approves the oncall agreement with Shawnee Mission Tree Service, Inc. dba Arbor Masters to provide tree trimming and removal services, attached hereto as Exhibit B and incorporated by reference, and authorizes the City Manager to execute the same or substantially similar.

SECTION 3. The City Manager, or designee, is further authorized to take such further action and execute such documents as may be necessary or desirable to carry out and comply with the intent of this Ordinance.

SECTION 4. This Ordinance shall be in full force and effect from and after the date of its passage and adoption, and approval by the Mayor.

SECTION 5. Should any section, sentence, or clause of this Ordinance be declared invalid or unconstitutional, such declaration shall not affect the validity of the remaining sections, sentences, or clauses.
