**B.** 2024-6264 Discussion: Liquor License Procedures

# **Council discussion included:**

Springfield, MO - 60% liquor / 40% food
Handful of businesses that are affected
Minors in bars - any known issues
Small downtown businesses
Buffers (UDO) requirements differ for restaurants and bars
Special event sales
No easy answers / no easy fix
Adjust to 55% liquor / 45% food
Conditional license for 1 year

After discussion, a consensus was reached by the Committee to have staff draft an ordinance to allow for a 1 year conditional license to those affected businesses and to present this to the City Council on June 4, 2024 for first reading. If approved it would move forward for second reading / adoption on June 11, 2024 which will meet the June 30, 2024 deadline for license renewals.
