AN ORDINANCE APPROVING A PUBLIC SERVICE AGREEMENT BETWEEN THE CITY OF LEE'S SUMMIT, MISSOURI AND DOWNTOWN LEE'S SUMMIT MAIN STREET, INC. FOR ORGANIZATION, PROMOTION, ECONOMIC VITALITY, AND DESIGN SERVICES FOR THE DOWNTOWN CORE, AND AUTHORIZING THE CITY MANAGER TO EXECUTE THE SAME BY AND ON BEHALF OF THE CITY.

WHEREAS, the City, by Ordinance No. 4611, imposed a license tax on certain gross receipts of hotels, motels and similar places of business, the proceeds of which were to be used to promote the general economic welfare of the City, including, but not limited to, the attraction and retention of business and industry to the community and/or the promotion and provision of facilities for tourism, conventions, and visitors; and,

WHEREAS, Downtown Lee's Summit Main Street, Inc. ("DLSMS"), a nonprofit corporation, assists the City by providing organization, promotion, economic vitality, and design services that attract and retain visitors, and business and industry to the City; and,

WHEREAS, the City of Lee's Summit ("City") currently has a Public Service Agreement for various services with Downtown Lee's Summit Main Street ("DLSMS") approved via Ordinance No. 9947; and,

WHEREAS, the City and DLSMS wish to continue the services outlined in the Public Service Agreement; and,

WHEREAS, the City has determined that it is in the best interests of the City, and important to the promotion of the general economic welfare of the City, to contract with DLSMS for the performance of various marketing related services as set forth in the attached public service agreement.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT, MISSOURI, AS FOLLOWS:

SECTION 1. The public service agreement between the City and Downtown Lee's Summit Main Street, Inc., attached as Exhibit A and incorporated herein by reference, is approved, and the City Manager is authorized to execute an agreement in substantially the same form as the attached by and on behalf of the City and to effectuate all documents or actions to implement the agreement.

SECTION 2. This Ordinance shall be in full force and effect from and after the date of its passage and approval.

SECTION 3. Should any section, sentence, or clause of this Ordinance be declared invalid or unconstitutional, such declaration shall not affect the validity of the remaining sections, sentences or clauses.
