- J. [BILL NO. 21-82](#) An Ordinance awarding the bid for Project No. 28531583 for the Boggs Hollow Meter Structure Project to Infrastructure Solutions, LLC in the amount of \$273,280.00 and authorizing the City Manager to execute an agreement of the same. (PWC 4/12/21)

A motion was made by Councilmember Carlyle, seconded by Vice Chair Edson, that this Ordinance be recommended for approval to the City Council. The motion carried by a unanimous 3-0 vote. (Councilmember Shields "Absent".)

- K. [BILL NO. 21-83](#) An Ordinance approving Modification No. 1 to an Agreement dated April 28, 2020, (RFQ No. 2020-046) for Professional Engineering Services for the Pryor Road Improvements from Longview Road to Hook Road project with TranSystems Corporation, for an increase of \$64,714 with an amended not to exceed amount of \$1,179,312, and authorizing the City Manager to execute an agreement for the same. (PWC 4/12/21)

A motion was made by Vice Chair Edson, seconded by Councilmember Carlyle, that this Ordinance be recommended for approval to the City Council. The motion carried by a unanimous 3-0 vote. (Councilmember Shields "Absent".)

- L. [BILL NO. 21-84](#) An Ordinance approving Modification No. 2 to an Agreement dated July 16, 2019 (RFQ No. 543-32272B) for Professional Engineering Services for Stormwater - SE Hackamore Drive & SE Secretariat Drive with Intuition & Logic Inc., for an increase of \$64,690.10 with an amended not to exceed amount of \$324,334.30 and authorizing the City Manager to execute an agreement for the same. (PWC 4/12/21)

A motion was made by Councilmember Carlyle, seconded by Vice Chair Edson, that this Ordinance be recommended for approval to the City Council. The motion carried by a unanimous 3-0 vote. (Councilmember Shields "Absent".)

- M. [BILL NO. 21-85](#) An Ordinance amending Chapter 29; Traffic and Motor Vehicles, of the Code of Ordinances for the City of Lee's Summit, Missouri, by revising Appendix B; Schedule of Stopping, Standing and Parking Restrictions, for certain streets and segments of streets located in the City of Lee's Summit. (PWC 4/12/21)

A motion was made by Vice Chair Edson, seconded by Councilmember Carlyle, that this Ordinance be recommended for approval to the City Council. The motion carried by a unanimous 3-0 vote. (Councilmember Shields "Absent".)

- N. [BILL NO. 21-86](#) An Ordinance authorizing the execution of an Agency Participation Agreement by and between the City of Lee's Summit, Missouri, (City) and the Mid-America Regional Council (MARC), and Traffic Technology Services, Inc. (TTS) in conjunction with the underlying Data Authorization Agreement between MARC and TTS, and the Operation Green Light Agreement between City and MARC, for the exchange of Real Time Traffic Signal Data for the City of Lee's Summit, Missouri. (PWC 4/12/21)

A motion was made by Councilmember Carlyle, seconded by Vice Chair Edson, that this Ordinance be recommended for approval to the City Council. The motion carried by a

unanimous 3-0 vote. (Councilmember Shields "Absent".)

6. Roundtable

Councilmember Edson mentioned she had the opportunity to go with Mr. George Binger, City Engineer, and Mr. Mike Anderson, Interim Public Works Director, to look at flooding in a nearby neighborhood and to discuss stormwater issues. It is a residential area ripe for development and redevelopment. She asked about low impact development and Mr. George Binger explained that it is land planning to manage stormwater runoff as part of green infrastructure, such as rain barrels and rain gardens. Councilmember Edson wondered if it would be appropriate for this committee to get more information from staff on this concept for parts of the City, what that looks like and whether or not to make changes to the Unified Development Ordinance, and applying it to certain areas. Christal Weber, Assistant City Manager, mentioned these are policies the Council could consider especially with moving forward with the stormwater utility. For example, developers being able to receive credits back towards the costs of their stormwater impacts. Mr. Binger mentioned having conversations with Ryan Elam, Director of Development Services, and with Josh Johnson, Assistant Director of Plan Services. The Development group is discussing ways to change the City's stormwater design criteria and this could be one concept. The question is how is it employed and the impacts. It might be a joint effort between the Public Works Committee and how it works with the City's infrastructure, and Community and Economic Development Committee on the development of the private side. Staff will put an informational presentation together for the Committee.

Mr. Binger mentioned the FY22 Capital Improvement Plan that is now on the City website for public viewing and comment. A summary report will be presented to City Council on April 20, 2021, as an overview. The City encourages residents to go to the website to comment. The CIP presentation is scheduled at the Public Works Committee on May 3, 2021, then to the City Council the following week.

7. Adjournment

The April 12, 2021, Public Works Committee meeting was adjourned by Chairman DeMoro at 6:05 p.m. at City Hall, 220 SE Green Street, City Council Chambers.
