## **BILL NO. 25-058**

AN ORDINANCE APPROVING A FIXED BASE OPERATOR AGREEMENT BETWEEN THE CITY OF LEE'S SUMMIT, MISSOURI AND SUMMIT FLIGHT ACADEMY, LLC TO PERFORM FLIGHT TRAINING AND AIRCRAFT RENTAL AT THE LEE'S SUMMIT MUNICIPAL AIRPORT AND AUTHORIZING THE MAYOR TO EXECUTE THE SAME.

WHEREAS, the City of Lee's Summit owns and operates the Lee's Summit Municipal Airport and,

WHEREAS, the Airport, through the City Council, periodically enters into agreements to enable the performance of various commercial aeronautical services on Airport property; and,

WHEREAS, Summit Flight Academy, LLC ("Operator") performs flight training and aircraft rental services; and,

WHEREAS, Operator desires to enter into a new FBO agreement to operate as an FBO out of the new LS Management Hangar; and,

WHEREAS, Operator and the City have negotiated the terms and conditions of a Fixed Base Operator Agreement which provides for the operations as an FBO; and,

WHEREAS, City and Operator wish to enter into the Fixed Base Operator Agreement.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT, MISSOURI, as follows:

SECTION 1. The City Council hereby approves An Ordinance approving a Fixed Base Operator Agreement between the City of Lee's Summit, Missouri and Summit Flight Academy, LLC to operate as a Fixed Based Operator (FBO) to provide flight training and aircraft rental at the Airport and authorizing the Mayor to execute the same, substantially similar to said agreement attached hereto as Exhibit A attached hereto and incorporated herein.

SECTION 2. The Mayor, or designee, is further authorized to take such further action and execute such documents as may be necessary or desirable to carry out and comply with the intent of this Ordinance.

SECTION 3. This Ordinance shall be in full force and effect from and after the date of its passage and adoption, and approval by the Mayor.

SECTION 4. Should any section, sentence, or clause of this Ordinance be declared invalid or unconstitutional, such declaration shall not affect the validity of the remaining sections, sentences, or clauses.
