AN ORDINANCE APPROVING A MUTUAL AID AGREEMENT BETWEEN THE CITY OF LEE'S SUMMIT, MISSOURI AND THE BOARD OF POLICE COMMISSIONERS OF KANSAS CITY, MISSOURI RELATED TO LAW ENFORCEMENT SERVICES PROVIDED IN SUPPORT OF FIFA WORLD CUP 2026 ACTIVITIES IN THE KANSAS CITY METROPOLITAN AREA, AND AUTHORIZING THE MAYOR TO EXECUTE THE SAME.

WHEREAS, the FIFA World Cup 2026 tournament will include activities and events hosted within the Kansas City metropolitan area requiring regional public safety coordination and support; and,

WHEREAS, the Kansas City Missouri Police Department (KCPD) is coordinating regional law enforcement assistance and operational support associated with FIFA World Cup 2026 related activities; and,

WHEREAS, KC2026 has been designated as the local organizing entity responsible for administration and reimbursement coordination associated with certain World Cup related public safety expenditures; and,

WHEREAS, the City of Lee's Summit Police Department may provide limited law enforcement resources, including specialized personnel and equipment, in support of FIFA World Cup 2026 activities; and,

WHEREAS, the proposed Mutual Aid Agreement establish the terms, conditions, and operational coordination associated with such assistance and participation.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT, MISSOURI, AS FOLLOWS:

SECTION 1. The City Council hereby approves the Mutual Aid Agreement between the City of Lee's Summit, Missouri and the Board of Police Commissioners of Kansas City, Missouri related to operational coordination for law enforcement services provided in support of FIFA World Cup 2026 activities, attached hereto as Exhibit A, and authorizes the Mayor to execute the same.

SECTION 2. This Ordinance shall be in full force and effect from and after the date of its passage and adoption, and approval by the Mayor.

SECTION 3. That all ordinances or parts of ordinances in conflict with this Ordinance are hereby repealed.
