

BILL NO. 25-225

AN ORDINANCE APPROVING THE USE OF A COOPERATIVE CONTRACT BETWEEN THE HOUSTON-GALVESTON AREA COUNCIL (HGACBUY) AND ROADWAY ASSET SERVICES, LLC. (CONTRACT NO. HP08-25), FOR THE EVALUATION SERVICES FOR THE CITY OF LEE'S SUMMIT ROADWAY SYSTEM AND STREET SIGNAGE AND AUTHORIZING THE CITY MANAGER TO EXECUTE THE SAME FOR THE CITY.

WHEREAS, the City of Lee's Summit, Missouri ("City") needs an evaluation of its roadway system to maintain pavement inventory infrastructure; and,

WHEREAS, Section 6.1 of the Procurement policy allows the City to make purchases from contracts that were originally procured by another entity, but have extended the pricing and terms of such contract to other entities, such as the City; and,

WHEREAS, the City is able to obtain the evaluation services pursuant to a contract between the Houston-Galveston Area Council (HGACbuy) and Roadway Asset Services, LLC; and,

WHEREAS, Section 4 of the Procurement Policy requires a cooperative contract with an estimated annual spend of \$75,000.00 or more to be approved by City Council before it is used; and,

WHEREAS, the City anticipates spending over \$75,000.00 annually on the pavement inspection services.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT, MISSOURI, as follows:

SECTION 1. The City Council of the City of Lee's Summit, Missouri hereby approves the City's use of the Houston-Galveston Area Council (HGACbuy) and Roadway Asset Services, LLC (Contract No. HP08-25), ("Cooperative Agreement"), and further approves the Contract Pricing Worksheet attached as Exhibit A and incorporated herein by reference, and authorizes the City Manager to execute all documents necessary to use the Cooperative Agreement for pavement and sign inspection.

SECTION 2. The City Manager, or designee, is further authorized to take such further action and execute such documents as may be necessary or desirable to carry out and comply with the intent of this Ordinance.

SECTION 3. This Ordinance shall be in full force and effect from and after the date of its passage and adoption, and approval by the Mayor.

SECTION 4. Should any section, sentence, or clause of this Ordinance be declared invalid or unconstitutional, such declaration shall not affect the validity of the remaining sections, sentences, or clauses.
