AN ORDINANCE APPROVING THE USE OF AN AGREEMENT BETWEEN THE CITY OF LEE'S SUMMIT AND KEY EQUIPMENT & SUPPLY COMPANY AND UTILIZING A SOURCEWELL COOPERATIVE CONTRACT TO PURCHASE AN EAGLE WATERLESS STREET SWEEPER, AND AUTHORIZING THE CITY MANAGER TO EXECUTE THE SAME FOR THE CITY.

WHEREAS, the City of Lee's Summit, Missouri (the "City") has a need to purchase a waterless street sweeper for the Public Works department as a part of the Vehicle Equipment Replacement Program ("VERP"); and,

WHEREAS, Key Equipment & Supply Company ("Contractor") utilized the Sourcewell cooperative contract for pricing; and,

WHEREAS, the cost of the Eagle Waterless Street Sweeper is quoted at \$415,074.90 and is included in the FY24 VERP budget; and,

WHEREAS, Section 6.1 of the Procurement policy allows the City to make purchases from contracts that are organized by third party aggregators that bring multiple entities together for purchasing; and,

WHEREAS, the City is spending over \$75,000.00 annually through this purchase utilizing the Key Equipment & Supply Company contract through the Sourcewell Cooperative Purchasing Agreement,

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT, MISSOURI, as follows:

SECTION 1. The City Council of the City of Lee's Summit, Missouri hereby approves an agreement between the City and Contractor utilizing the Sourcewell Cooperative Purchasing Agreement, attached as Exhibit A and incorporated herein by reference to purchase a waterless street sweeper for the price of \$415,074.90 and hereby ratifies the City Manager's signature of the agreement on behalf of the City.

SECTION 2. This Ordinance shall be in full force and effect from and after the date of its passage and adoption, and approval by the Mayor.

SECTION 3. Should any section, sentence, or clause of this Ordinance be declared invalid or unconstitutional, such declaration shall not affect the validity of the remaining sections, sentences, or clauses.
