Discussion: Update from Lobbyist

Brian Head briefed the Committee on the Lobbyist Report previously sent to them as follows:

1. HB105: Land Transfer Bill regarding the 291 N/50 Hwy project. This bill passed through the Senate and has been sent to the Governor.
2. HB8: Appropriations Bill: We are waiting to see if anything is removed from the Bill by the Governor before passing.
3. HB145: Modifies provisions of the Sunshine Law to protect citizen information from "data miners".

Further discussion revolved around:

HB 19: The Committee would like Staff to look into this Bill as there are conversations in the community regarding \$50M that was cut from the Bill.

Brian is planning to invite the Lobbyists to come to the City Council meeting on July 15, 2025 to provide their end of session report.
