
### Commercial

- TIF
- CID 1% sales tax
- TDD 1% sales tax
- Ch. 100 sales tax exemption (each project > \$4MM cap ex)

## Residential

- Ch. 100
  - Fixed PILOTs
    - Area 1: \$2,776/unit + 3% biennial inflator
    - Area 5 (one phase/~300 units): \$1,800/unit + 3% biennial inflator
  - Sales tax exemption on construction materials
