- B.** [2026-7451](#) Public Hearing: Paragon Star Apartments Amended and Restated Land Clearance Redevelopment Authority Redevelopment Plan; Grayson Capital, LLC, applicant.

Ms. Andrea Young, Grayson Capital, presented the conceptual development plan. This will be done in three phases with the understanding that occupancy cannot occur until the required interchange construction is completed.

Ms. Megan Miller, Gilmore & Bell, presented on the current Lease Agreements and noted this plan was recommended for approval by the Land Clearance Redevelopment Authority on February 25, 2026.

Exhibits 1-8 were entered into the record.

- 1) [BILL NO. 26-039](#) An Ordinance approving the amended and restated Paragon Star Apartments Land Clearance for Redevelopment Authority (LCRA) Redevelopment Plan and approving the redevelopment contract and lease agreement for the project in connection therewith.

There was council discussion on how to proceed with this item as there was a consensus that many aspects of this project have not been fulfilled and trust has been broken. While Grayson Capital is not Paragon Star, there is still a hesitancy to move this forward with major construction on the interstate not completed. It was decided to table this item until a future date.

Councilmember Hodges noted she would be a no vote for the Ordinance or for tabling.

Councilmember Funk noted he was not in favor of it being a three phase project - would prefer it built as one phase or have assurances for the three phase project. Was ok with tabling.

Councilmembers Prier, Carlyle, Shields, Rader and Mayor Pro Tem Lopez all agreed the Paragon Star development has not met expectations, but were ok to table this to a later date.

Councilmember Lovell recused himself from this vote.

- C. [2025-7407](#) Public Hearing: Application #PL2025-079 - Rezoning from AG to RP-1, RP-4 and CP-2 & Preliminary Development Plan - Legacy Ridge, 815 SW Hook Road; Griffin Riley Property Group, applicant.

Mr. Jake Loveless, Griffin Riley Property Group, presented on the preliminary development plan. He noted they took in a lot of feedback from the Planning Commission and citizens to rework the development to address the concerns about apartments and density issues. They ultimately removed the apartments and will build all for sale town homes and single families homes with a smaller portion of villas for rent. To address the density issues, they decreased the number of homes being built.

Mr. Hector Soto, Senior Planner, presented on behalf of the City. Exhibits A, 1-24 were entered into the record.

It was noted that this development was recommended for approval by the Planning Commission.

The Mayor and Council were very appreciative of the developer hearing the concerns of the citizens and adjusting the plans accordingly.

The following citizens commented on this Public Hearing:

Ms. Deborah Giddings - in favor of RP-3 zoning; good example of conceptual planning

Mr. Zak Al-Shawish - likes that the apartments were removed, but still thinks the development is too dense.

Ms. Teresa Vollenweider - requested to know if the survey was signed and sealed.

Councilmember Rader asked if there was any push back on the rentals and how the developer will guarantee the "for sale" homes remain "for sale" and not turn into rentals. Mr. Loveless stated there was not push back on the rental properties and noted the neighborhood would be managed by an HOA who could address that.

There was council discussion on whether RP-4 or RP-3 zoning would better suite the area. Mr. Soto advised the only difference between the two is RP-4 would allow for apartments, but still required council approval for the development. It was decided to amend the Ordinance to RP-3 zoning and then advance to second reading.

D. [2026-7500](#) Public Hearing: Sewer Rates & Charges

Scott Ison, Chief Counsel of Infrastructure and Recreation, presented for the City.

Exhibits 1-3 were entered into the public record.

He spoke on the fee increases that would be occurring through 2033 (4%). These changes were recommended for approval by the Water Utilities Advisory Board due to an increase in chemical fees and fees from the water we purchase from surrounding areas.

The following citizens commented on this public hearing:

Ms. Deborah Giddings - was not aware this board was even meeting and again found it hard to know this information

Ms. Teresa Vollenweider- questioned why the City was paying for repairs for private lines. Mr. Jeff Thorn, Director of Water Utilities, responded stating that water utilities has an agreement to pay for the repairs of private lateral sewer lines if they meet certain requirements. This is due to some private lines going under the public roadway and being intertwined with other utilities. The Water Department would prefer to take on those repairs due to the potential for complexity. He also advised their budget for the repairs, if needed, is \$250,000. So far, they have never had to do a project.

Councilmember Prier asked what would happen if they did not approve to increase the fees? Mr. Thorn replied it would cause a lower level of service and hinder their ability to maintain infrastructure.

6. Public Comments:

The following citizens spoke during public comments:

- Deborah Giddings - had questions on the Ignite Plan and wanted to know when it was last reviewed. Expressed again how difficult it is to find information on the website. Mayor Baird addressed her questions on the Ignite campaign and stated that evaluation was done and recommendations were noted.

- Chip Floyd - spoke on his disapproval of the camera angle being changed during public comments.

Mr. Dunning responded stating this was a decision he made to ensure video from council meetings cannot be used as campaign materials. It is a violation of code of conduct for elections and is not an appropriate use of a tax payer funded function.

Councilmember Rader and Lovell noted they think the camera angle should go back to how it was with Councilmember Lovell concerned this could lead to potential censorship down the road.

Councilmember Prier, Shields and Hodges were ok with the recommended changes as the public is still able to speak and everything is heard and recorded for public record. Councilmember Hodges stated she believes there was either a statute or code of conduct "out there" that does not allow for this. If someone does misuse council media, are there repercussions? Mr. Dunning noted he would look further into that to see what action could be taken.

- DJ Good - directed his comments at Councilmember Rader as he believes she has lied and spread misinformation through her mayoral campaign about crime rates, the people opposed to single hauler trash, incentives for developers, and the decline of Lee's Summit schools. Mayor Baird requested Mr. Good to "bring the temperature down on this". Councilmember Rader responded and provided clarification on his statements: When she initially stated crime had increased in the City, she was using the data provided at the time. In response to the single hauler trash initiative, when their town hall survey was completed, 65% of residence were not in favor of it. She also emailed and spoke to many residents and passed all those communications to Michael Park, Director of Public Works, for documentation. On the incentives, she did not want to incentivize apartments; however, trends have changed so maybe she can consider looking into incentives for single-family residential. She has never stated the schools were in decline, but rather the population in schools has declined.

- Andrew Elsen - expressed his opposition to Ord. 26-041

- Susan Coffman - thanked the council for all the work they do and shared on her experience running for election and the boards and commissions she has served on.

- Teresa Vollenweider - showed a video of an interaction between her and the Lee's Summit Police Department. Councilmember Hodges noted they have seen this video before and Ms. Vollenweider did not show the part where she bit the police officer and also believes Ms. Vollenweider shows continuous disrespect to her neighbor.

A brief recess was take at 10:15pm. Session re adjourned at 10:25pm.
