AN ORDINANCE APPROVING THE AWARD OF RFP NO. 2026-046 FOR EMS BILLING AND COST RECOVERY SERVICES FOR A THREE-YEAR TERM, WITH UP TO TWO ONE-YEAR RENEWALS TO EMS MANAGEMENT & CONSULTANTS, INC. (EMS|MC) AND AUTHORIZING THE CITY MANAGER TO EXECUTE THE SAME BY AND ON BEHALF OF THE CITY OF LEE'S SUMMIT, MISSOURI.

WHEREAS, the City of Lee's Summit, Missouri (the "City") requires the services of an emergency medical billing firm to assist in the invoicing of ambulance transports and emergency medical services provided by the City; and,

WHEREAS, emergency medical billing services are specialized services performed by a number of well qualified regional and national firms; and,

WHEREAS, the contract with the City's current provider, EMS Management & Consultants, Inc. (EMS|MC), has expired; and,

WHEREAS, the City anticipates spending over \$75,000, because of this, and in accordance with City Procurement Policy, Section 4.4, the City issued RFP No. 2026-046 to solicit proposals from qualified firms to provide the required services; an

WHEREAS, of the proposals received in response to RFP No. 2026-046, EMS Management & Consultants, Inc. (EMS|MC), was the highest-ranking firm by the evaluation committee,

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT, MISSOURI, AS FOLLOWS:

SECTION 1. The City Council hereby authorizes the award of RFP No. 2026-046 to Fire Recovery EMS, LLC.

SECTION 2. The City Council approves an agreement between the City and EMS Management & Consultants, Inc. (EMS|MC), attached as Exhibit A and incorporated herein by reference, for EMS billing and cost recovery services for a three-year term, with up to two, one-year renewals, and authorizes the City Manager to execute the same in substantially the same form as the attached on behalf of the City.

SECTION 3. This Ordinance shall be in full force and effect from and after the date of its passage and adoption, and approval by the Mayor.

SECTION 4. Should any section, sentence, or clause of this Ordinance be declared invalid or unconstitutional, such declaration shall not affect the validity of the remaining sections, sentences, or clauses.
