## **BILL NO. 24-207**

AN ORDINANCE AWARDING THE BID FOR PROJECT NO. 575 FOR THE 3<sup>RD</sup> STREET IMPROVEMENTS FROM JEFFERSON STREET TO BLUE PARKWAY TO MILES EXCAVATION, INC. IN THE AMOUNT OF \$6,249,762.81 AND AUTHORIZING THE CITY MANAGER TO EXECUTE AN AGREEMENT FOR THE SAME.

WHEREAS, the 3rd Street Improvements Project was authorized by voters as part of the renewal of the Capital Improvements Sales Tax in 2017; and,

WHEREAS, City Council initially programmed funding for the project as part of the FY2021 Capital Improvement Plan (CIP); and,

WHEREAS, Public Works Engineering issued a bid for Project No. 575 on September 27, 2024, in accordance with local policies and state statutes; and,

WHEREAS, Miles Excavation, Inc. (hereinafter "Contractor") was determined to be the lowest and most responsible bidder by City Staff; and,

WHEREAS, the requested amount is for the Base Bid plus Alternate A; and,

WHEREAS, the City and Contractor desire to enter into an agreement to construct Project No. 575.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT, MISSOURI, as follows:

SECTION 1. The City Council of the City of Lee's Summit, Missouri hereby awards the bid for Project No. 575 to the Contractor in the amount of \$6,249,762.81.

SECTION 2. The agreement between the City of Lee's Summit, Missouri, and the Contractor, attached hereto as Exhibit A and incorporated by reference, is hereby approved, and the City Manager is hereby authorized to execute the same or substantially similar on behalf of the City of Lee's Summit, Missouri.

SECTION 3. The City Manager, or designee, is further authorized to take such further action and execute such documents as may be necessary or desirable to carry out and comply with the intent of this Ordinance.

SECTION 4. This Ordinance shall be in full force and effect from and after the date of its passage and adoption, and approval by the Mayor.

SECTION 5. Should any section, sentence, or clause of this Ordinance be declared invalid or unconstitutional, such declaration shall not affect the validity of the remaining sections, sentences, or clauses.
