

BILL NO. 26-016

AN ORDINANCE AWARDING THE BID FOR PROJECT NO. 205 FOR THE BOWLIN TANK – RECOATING TO CUNNINGHAM SANDBLASTING & PAINTING CO. IN THE AMOUNT OF \$677,100.00, AND AUTHORIZING THE CITY MANAGER TO EXECUTE AN AGREEMENT FOR THE SAME.

WHEREAS, the project consists of recoating the interior, spot coating repairs to the exterior, and exterior grout replacement on Bowlin Tank. Bowlin Tank was last recoated and repaired in 2008; and,

WHEREAS, Project No. 205 is funded by the Water Equipment Replacement Fund for FY2026; and,

WHEREAS, Water Utilities issued a bid for Project No. 205 on November 5, 2025, in accordance with local policies and state statutes, and opened bids on December 17, 2025; and,

WHEREAS, Cunningham Sandblasting & Painting Co. (“Contractor”) was determined to be the lowest and best responsible and responsive bidder by City staff; and,

WHEREAS, the City and Contractor desire to enter into an agreement for Project 205.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT, MISSOURI, as follows:

SECTION 1. The City Council of the City of Lee’s Summit, Missouri, hereby awards the bid for Project No. 205 to the Contractor in the amount of \$677,100.00.

SECTION 2. The agreement between the City of Lee’s Summit, Missouri, and the Contractor, attached hereto as Exhibit A and incorporated by reference, is hereby approved, and the City Manager, or designee, is hereby authorized to execute an agreement substantially similar to the same on behalf of the City of Lee’s Summit, Missouri.

SECTION 3. The City Manager, or designee, is further authorized to take such further action and execute such documents as may be necessary or desirable to carry out and comply with the intent of this Ordinance.

SECTION 4. This Ordinance shall be in full force and effect from and after the date of its passage and adoption, and approval by the Mayor.

SECTION 5. Should any section, sentence, or clause of this Ordinance be declared invalid or unconstitutional, such declaration shall not affect the validity of the remaining sections, sentences, or clauses.
