B. 2025-6711 Public Hearing: Community Development Block Grant 2025-29 Consolidated Plan and 2025-26 Annual Action Plan

Jessica Fisch, with Mosaic Community Planning, presented an overview of the 2025-29 CDBG Consolidated Plan, which included the plan objectives, community engagement efforts, community survey results, timeline and goals.

Amy Koeneman, with JEO Consulting Group, is assisting the City of Lee's Summit with its CDBG program. She reviewed the timeline, funding caps and prioritization process for the 2025-26 Annual Action Plan. Since HUD has not announced the amount of funding for this year (but has confirmed the program will be funded), staff is basing the anticipated funding amount on last year's allocation of \$342,628.00 + \$173,000.00 prior year funds available for reallocation for a grand total of \$515,628.00.

A representative from each of the following organizations presented information about their funding requests followed by a review of staff's funding recommendations for each organization.

After discussion, the CEDC approved staff's recommendations as indicated below:
