B. 2024-6347 Discussion: Mayoral succession beyond Mayor Pro Tempore

Brian Head went over the draft language he prepared that was similar to what was referenced in the Independence, Missouri Code. He mentioned that it would be placed in Ordinance form. He wanted the Committee to know it would be placed in the Emergency Preparedness section of the Code once approved.

After brief discussion, a motion was made.

Councilmember Carlyle made a motion to recommend the mayoral succession language to the Council for approval. Motion was seconded by Councilmember Hodges. Motion passed with vote of 4-0.

C. 2024-6425 Discussion: Televising of Boards and Commissions

Chairperson Shields shared a spreadsheet of the Boards, Committees and Commissions that she prepared.

The Committee went through the spreadsheet and discussed the following:

- 1. The importance of continuing to broadcast those meetings that are currently broadcast
- 2. Adding a definition for "Task Force" and leaving those meetings, depending on the topic, up to the discretion of the Council if it should be included as a meeting to recorded or broadcast.
- 3.Options regarding logistics of meetings and if they could be recorded or broadcast in specific rooms and if additional staffing would be a concern.
- 4. Determining which meetings are being viewed by citizens and if it is worthwhile to have them recorded if there are not many viewers.
- 5. If it is necessary to have all meetings recorded and broadcast live.
- 6. The need to update the Resolution with how technology is used today.

Ms. Nash and Mr. Head will meet with Management Team to discuss this information and determine their thoughts on this item and if they have any concerns in light of the Committee's discussion.

Discussion on this topic will continue at the next meeting.
