3. Council Roundtable

Councilmember DeMoro reminded everyone that June 5, 2019 at 5:30 p.m. will be the Hartman Park Rock Island Trail ribbon cutting. He stated that this trail head is a great addition to Hartman Park and the Rock Island Trail.

Councilmember Forte announced Downtown Days is this weekend. Madison Ward and the Mama Bear are the headline act for Saturday evening starting at 8:30 p.m. The festival opens at noon on Friday, June 7 and lasts until Sunday, June 9. Also, Lee's Summit CARES hosted their annual Got Talent fundraiser and they raised \$22,000 to support Lee's Summit CARES and their Community for Youth and Family. The three judges were Matt Lewis, who performed a 30 minute pre-show much to the delight of the fans, and former graduates Steve Serrano and Christina Burton. The top 3 winners were Sam Aubuchon, age 18, from Blue Springs, Jordan Haas, age 17, from Lee's Summit, and Emma Hite, age 12, from Belton.

Councilmember Edson shared that last week Councilmember DeMoro and herself met with Governor Mike Parson at Hy-Vee on 3rd Street and Ward Road. The Department of Agriculture held a "Celebration to Beef" (May is National Beef Month). She added that the Chef at Hy-Vee prepared some very tasty beef and it was a good event.

Councilmember Johnson mentioned this weekend there is a girls softball tournament at Legacy Park. The tournament is fast pitch for youth ages 10, 12 and 14.

Councilmember Binney expressed his hope that the girls softball teams are staying in Lee's Summit hotels and eating at Lee's Summit restaurants. Mr. Will Dyson, HOA President of Silvertooth-Fahey Farms in Kansas City, shared his concerns with the 404 permit from the Corp of Engineers NWK 2013-00408 has a condition R which states you are prohibited from filling any wetlands, or effecting the wetlands, whether they are in the floodway or not. He stated that clearing and grading has been done at the site that accelerates and increases the drainage. He added that the HOA includes horse pastures that have never flooded until this year and now half the pastures and fences are under water. He feels the 404 condition R should be honored and the filling and changing of these wetlands should be undone. A large storm would threaten their community.
