8. Committee Reports

There were not any Committee Reports.

9. Council Comments:

Councilmember Forte asked if there is a policy stating city employees cannot put up yard signs for municipal elections. Mr. Steve Arbo, City Manager, stated he would need to research to see if a policy exists but he does discourage it because staff needs to remain unbiased. When asked about Police and Fire using signs to advertise their support, Mr. Arbo explained they are doing so as representatives of their union and not as city employees.

Councilmember DeMoro reported the reopening of the South Recycling Center on Hamblen Road. Grants from MARC (Mid-America Regional Council) and MDNR (Missouri Department of Natural Resources) were utilized to purchase roll off containers to make this possible.

Councilmember Johnson furthered the discussion about employees placing political signs in their yards. Mr. Steve Arbo, City Manager, said there probably is not a policy because it would infringe on the employees first amendment rights but there is a culture to not do so in order to keep politics out of the workplace.

Mayor Baird shared that he traveled with Councilmember Edson, Councilmember Binney and City Manager Steve Arbo to Jefferson City to attend the Missouri Municipal League Conference. They met with several Senators and Representatives to build relationships and show their support. A few of the topics they discussed were moving the Highway Patrol building, partnering with MoDOT on projects and the Franchise Tax Bill which is still out there and would cost Lee's Summit around a million dollars a year.

10. Staff Roundtable

Mr. Steve Arbo, City Manager, voiced appreciation to Councilmember Johnson for opening doors with Senators, State Representatives and some agencies to aid conversations for moving the Highway Patrol building and the 291 North Interchange project. He then gave further details regarding Budget Amendment No. 6 (Bill No. 20-36) rolling forward to the next fiscal year the remaining balance of the unspent, previously approved expenditures.
