Public Hearing: Application #PL2022-357 - Rezoning from RP-2 to CP-2 and Preliminary Development Plan - Take 5 Oil Change, 400 NE M-291 Highway; Driven Assets, LLC, applicant.

(Note: This application was continued from November 21, 2023 and May 7, 2021 per the applicant's request.)

Mr. Shannon McGuire, Senior Planner entered Exhibits 1 - 19 into the record.

Council discussion included:

- Concerns with drainage? None
- Connection to next retail center parking lot
- No access to other properties beside the retail center to the south

Mr. Lester Massood, stated an incorrect address was used for notification, inadequate signage and feels applicant did not follow the correct policy and procedure. He did not agree with the zoning change as it opens it up to several different kinds of business that is not desired in that area.

Mr. Michael Massood spoke in opposition to the project and did not feel the notification was done correctly. He would like to see this area stay with residential area to keep the peace for his residents of Summit East.

Mr. Theron Denson, resident of Summit East Plaza and he is worried about the traffic and noise pollution from this application.

Mr. Thomas Zammar spoke in opposition to this project due to concerns of drainage and water flow and retention and the safety of residents at Summit East Plaza.

Ms. Kathy Boas, resident of Summit East Plaza, spoke in opposition to the application as this apartment complex is very close to this project and feels the water drainage is an issue as well as the possibility of other businesses going in this location if it rezoned.

Mr. Michael Nelson, resident of Summit East Plaza, stated he was concerned with not being notified of this public hearing by the applicant. He shares the concerns regarding the water drainage and additional noise pollution in the area.

Ms. Lisa Baldwin, resident Summit East Plaza, also spoke in opposition of this application and feels this project is better suited to an area that is not currently zoned as residential and in an area that is more complimentary than this location. She also stated there would be 4 oil change businesses within a mile of each other if this business went in this location.

Ms. Rebecca Shepard-Brimager stated part of her property abuts hat butts up to the vegetation area. She is worried about the possible effect on her property value and

Mr. Carnmer stated he is opposed to this application because he feels this will cause traffic issues including congestion and parking issues in this area.

Ms. Jeanine Micheals advised someone stated this was a "much needed service" but she did not feel that this is true as there are similar to several other businesses in the area that does the same thing. She shared concerns about the noise from the business being disruptive as well.

Ms. Teresa Vollenweider asked to see signed, sealed and dated plans with a table of revisions to protect the public from changes being made without their knowledge.

No one was present to speak in favor of this application.
