- A.** [2020-3426](#) COVID-19 Update

Mr. Mike Snider, Fire Chief, provided a review and update of the current situation regarding the COVID-19 pandemic. He advised he has been working very closely with the Jackson County as they are the local authority having jurisdiction during this public health emergency. He advised there is a lot of required protocol for first responders to keep them safe. But there are many ways the public can help, mostly by staying at home during the Shelter In Place orders.

Mr. Snider stated currently there are 235 cases in Jackson County with 9 deaths; 346 cases in Kansas City with 11 deaths; 1402 in this region with 62 deaths. The City continues to learn and take the best possible precautions to prevent further spread of this disease.

Mr. Steve Arbo, City Manager, stated he continues to work closely with MARC (Mid America Regional Council) which represents 119 municipalities in 9 counties and has over 2 million people. They work together to help plan future measures to mitigate the losses of this pandemic both in health and well being

of citizens and financial hardships.

#### 4. Council Roundtable

Councilmember Forte gave a shout out to the local businesses and restaurants in Lee's Summit. She is thank for everyone that is continuing to support them and she hopes more people will help or continue to do so.

Councilmember Binney applauded the IT staff for helping everyone be able to attend this meeting virtually. He stated public transportation has also been impacted and there is a reduced amount of busses available for commuting. He too is proud of the community as a whole.

Mayor Baird expressed his appreciation to the community for coming together in this time of need. He has seen several donations of masks and shields provided to 1st responders and hospitals. Everyone is helping each other as much as we can. Through this we can actually begin to speculate a time when we will reach the peak and start working our way to the other side of this pandemic.

Councilmember Faith reflected on the recent death of Bill Birmingham. Mr. Birmingham was a 1st responder with the Kansas City Fire Department, but he resided in Lee's Summit. He was once employed by John Knox Village and will be remembered as a great man.
