**B.** 2024-6534 Discussion: Housing Initiatives: updates and recommendations

Aimee Nassif, Interim Director of Development Services, updated the Committee on current housing data and initiatives. Staff provided the following recommendations on how to move forward:

## **UDO and Code Process:**

- 1. Draft Infill Development Policy.
- 2. Review UDO for additional housing opportunities in residential districts.

## **Community Engagement and Partnerships:**

- 1. Look into a home buyer education workshop.
- 2. Develop strategies to promote housing diversity awareness and advocates.

## **Economic Incentives and Assistance:**

- 1. Explore Neighborhood Improvement Program
- 2. Provide details on a first-time home buyer's assistance program.
- 3. Provide information on land bank programs.

After discussion, the committee agreed to all the recommendations mentioned.

**C.** <u>2024-6605</u> Discussion: Review Processes for City Development Projects

Shannon McGuire, Planning Manager, reviewed the process for city development projects and stated the City's Code of Ordinance outlines all the requirements. He further added that city projects are held to the same standards as the rest of the community.

**D.** <u>2024-6604</u> Discussion: Property Enforcement, Maintenance, and Enhancement

Steve Robbins, Assist. Dir. of Field Services, provided information pertaining to the property enforcement process, which includes property maintenance, management and enhancement. Additionally, he presented information from other local communities for comparison. Following the presentation discussion ensued.
