



**AMENDMENT NO. 1 to CONTRACT NO. 2024-033**

This First Amendment to Contract 2024-033 ("Amendment") is entered into between the City of Lee's Summit, Missouri (the "City") and Versa Governmental Strategies LLC ("Vendor").

**Recitals**

WHEREAS, the City issued RFP #2024-033 and awarded Contract 2024-033 pursuant to the RFP to Vendor dated December 1, 2023 ("Contract 2024-033") to provide Legislative and Intergovernmental Services; and

WHEREAS, the parties desire to amend Contract 2024-033 to add the additional service of lobbying representation for the City on federal government issues from the vendor for an additional sum of \$5,000 per month or \$50,000 for the remaining contract term, which provides for an amended total expenditure to this vendor of up to \$110,000 for the year 2026.

**NOW THEREFORE**, the Parties to this Amendment, for good and valuable consideration agree to the following:

Section 1: Effective February 1, 2026 Versa Governmental Strategies LLC shall provide lobbying representation for the City on federal government issues for the additional sum of \$5,000 per month or \$50,000 for the remainder of the contract term as reflected in the Federal Lobbying Services Proposed Term Sheet dated December 18, 2025, attached hereto as Exhibit 1 to this amendment.

Section 2: The parties hereby agree that this entire agreement now consists of the following documents:

1. The Services Agreement between the parties executed December 18, 2023
2. Versa's response to RFP 2024-033 attached as Exhibit 1 to the Services Agreement of December 18, 2023
3. This Amendment No. 1 to Contract No. 2024-033 between the City and Versa Governmental Strategies.
4. Federal Lobbying Services Proposed Term Sheet dated December 18, 2025, attached hereto as Exhibit 1.

Section 3: The term of this agreement amendment shall be the same as Contract No. 2024-033 ending November 30, 2026.

Section 4: Except as otherwise amended by this Amendment, all other terms and conditions of Contract 2024-033, as amended, shall remain in full force and effect. This Amendment shall be deemed a contract in accordance with the laws of the State of Missouri.
