AN ORDINANCE AWARDING BID NO. 34131583-C, FOR THE SOUTH PRAIRIE LEE INTERCEPTOR SEWER AT CRYSTAL VIEW ESTATES TO WIEDENMANN INC., IN THE AMOUNT OF \$168,000.00 AND AUTHORIZING THE CITY MANAGER TO EXECUTE AN AGREEMENT FOR THE SAME.

WHEREAS, the South Prairie Lee Interceptor Sewer Project at Crystal View Estates (the "Project") will serve existing customers and development customers by upsizing two segments of sanitary sewer line which are currently at or over design capacity based on complete development of the area served by the sanitary sewer; and

WHEREAS, one of the sewer segments is being upsized to increase capacity for a new development upstream of the project located southeast of the intersection of SE Shanandoah Drive and SE Battery Drive known as "Village Cooperative".

WHEREAS, the Developer already paid the City of Lee's Summit \$81,300.00 which was the estimated cost for upsizing one sewer segment to provide service to the Village Cooperative development.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT. MISSOURI, as follows:

SECTION 1. That the City Council of the City of Lee's Summit, Missouri hereby authorizes the award of Bid No. 34131583-C to Wiedenmann, Inc for the South Prairie Lee Interceptor Sewer Project at Crystal View Estates.

SECTION 2. That the City Council of the City of Lee's Summit hereby authorizes the execution, by the City Manager, of an agreement with Wiedenmann, Inc. for the services contained in Bid No. 34131583-C generally for the South Prairie Lee Interceptor Sewer Project at Crystal View Estates in an amount not to exceed \$168,000.00, a true and accurate copy of said contract is on file with the City of Lee's Summit Public Works Department and is incorporated by reference as if fully set forth herein.

SECTION 3. That this Ordinance shall be in full force and effect from and after the date of its passage and adoption, and approval by the Mayor.
