
Neighborhood Protest - The Townhomes of Chapel Ridge 3rd Plat

Regarding Lee's Summit Permit Application Nos. PL2024120 and PRSUBD20242255, associated with The Townhomes of Chapel Ridge 3rd Plat, CHOYCE LLC, has proposed development of this area which **violates current zoning** and the Preliminary Development Plan (PDP) approved by the City council on January 14, 2020.

CHOYCE LLC has proposed constructing multi-family housing on the **West** side of NE Chapel Ridge Place and on the **North** side of NE Sundown Dr immediately adjacent to an existing home. **These areas are zoned for single family housing.** The PDP approved 1/14/2020 specifically shows six (6) single family lots on the West side of NE Chapel Ridge Place and three (3) single family lots on the North side of NE Sundown Dr, adjacent to 608 NE Sundown Dr. The current 2024 permit application shows seven (7) lots in this same area with designations for multi-family homes. Furthermore, the proposed Green Space on the North side of NE Sundown Dr (Tract F) is less than 20% of Green Space approved in 2020 (Tract C).

As residents of The Estates of Chapel Ridge (and Lakewood Property Owners Association), we hereby declare our strong opposition to the plan to construct multi-family housing on lots currently zoned for single family housing.
