

## **The Pulse Legal Publications – subscription and publication pricing**

- Subscription is \$20 per month to receive daily newspaper either by hard copy or digitally.
- The cost of publication is \$0.72 per line, plus \$0.72 for each space between the lines

Example: two publications of a notice that is 30 lines and 30 spaces.

Cost:  $\$43.20 \times 2 = \$86.40$

- If the publication has a graphic or map included in the publication there is a one-time charge of \$5 per graphic regardless of how many times the publication runs.
- The Pulse is part of the Missouri Press (mo.press.com) which allows the City to look up any legal notice on their website for no additional charge.
- Pulse has an average of 177 hits from the Missouri Press's online website; 132 paper paid subscriptions; and 255 online paid subscribers

Below is an example of public hearing notice posted in the Pulse. Cost was \$21.00

## Lee's Summit Tribune – subscription and publication pricing

- The Tribune charges by column width and height.
- Pricing is \$6.00 per column inch.
- When a map is included, it becomes part of the column inch pricing, without a separate charge.

Example: A column that is 3” wide and 2.5” tall = 7.5 column inches x \$6 = \$45.00

The map below is an example of a public hearing posted in the Tribune which cost \$45.00.
