AN ORDINANCE APPROVING MODIFICATION NO. 1 TO AN AGREEMENT FOR PROFESSIONAL ENGINEERING SERVICES FOR SAMPSON ROAD BRIDGE REPLACEMENT AND STORMWATER IMPROVEMENTS (RFQ NO. 2023-041) WITH WILSON AND COMPANY, FOR AN INCREASE OF \$573,340.00 WITH AN AMENDED NOT TO EXCEED AMOUNT OF \$1,157,875.00 AND AUTHORIZING THE CITY MANAGER TO EXECUTE AN AGREEMENT FOR THE SAME.

WHEREAS, pursuant to Ordinance No. 9648, the City and Wilson & Company entered into an Agreement for Professional Engineering Services for SAMPSON ROAD BRIDGE REPLACEMENT AND STORMWATER IMPROVEMENTS (RFQ No. 2023-041) (hereinafter "Base Agreement"); and

WHEREAS, Wilson & Company (hereinafter "Engineer") has submitted a proposal with estimated costs to provide additional engineering services during the construction of the Sampson Road Bridge Reconstruction and Stormwater Improvements; and

WHEREAS, the City desires to modify the Base Agreement, with Engineer to provide said construction phase services (hereinafter "Modification No. 1").

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT, MISSOURI, as follows:

SECTION 1. The City Council of the City of Lee's Summit, Missouri, hereby approves Modification No. 1 for an increase of \$573,340.00 with an amended not to exceed amount of \$1,157,875.00, as attached hereto as Exhibit 1.

SECTION 2. The City Council of the City of Lee's Summit, Missouri, hereby authorizes the City Manager to execute the same on behalf of the City of Lee's Summit, Missouri.

SECTION 3. The City Manager, or designee, is further authorized to take such further action and execute such documents as may be necessary or desirable to carry out and comply with the intent of this Ordinance.

SECTION 4. This Ordinance shall be in full force and effect from and after the date of its passage and adoption, and approval by the Mayor.

SECTION 5. Should any section, sentence, or clause of this Ordinance be declared invalid or unconstitutional, such declaration shall not affect the validity of the remaining sections, sentences, or clauses.
