## **BILL NO. 24-211**

AN ORDINANCE APPROVING AWARD OF RFQ 2025-023 TO AFFINIS CORPORATION AND TO WILSON & COMPANY, INC., FOR ON-CALL PROFESSIONAL LAND SURVEYING SERVICES, AND AUTHORIZING THE CITY MANAGER TO EXECUTE INDIVIDUAL AGREEMENTS OF THE SAME FOR A PERIOD OF ONE YEAR WITH FOUR POSSIBLE ONE-YEAR RENEWALS.

WHEREAS, the City uses on-call surveying services to support several departments; and,

WHEREAS, City staff issued RFQ No. 2025-023 seeking qualified firms to provide on-call surveying services (hereinafter "Services"); and,

WHEREAS, after review of those submissions for RFQ No. 2025-023, Affinis Corp. and Wilson & Company, Inc were selected based on their qualifications and varied expertise; and,

WHEREAS, funding for the Services is provided by specific projects or programs approved by Council in the City's annual operating budget or Capital Improvement Plan; and,

WHEREAS, the City desires to enter into an agreement with each firm to provide the Services.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT. MISSOURI, as follows:

SECTION 1. The agreement between the City of Lee's Summit, Missouri and Affinis Corp. to provide the Services, attached hereto as "Exhibit A" and incorporated by reference, is hereby approved and the City Manager, or designee, is hereby authorized to execute an agreement substantially similar to the same on behalf of the City of Lee's Summit, Missouri.

SECTION 2. The agreement between the City of Lee's Summit, Missouri and Wilson & Company, Inc. to provide the Services, attached hereto as "Exhibit B" and incorporated by reference, is hereby approved and the City Manager, or designee, is hereby authorized to execute an agreement substantially similar to the same on behalf of the City of Lee's Summit, Missouri.

SECTION 3. The City Manager, or designee, is further authorized to take such further action and execute such documents as may be necessary or desirable to carry out and comply with the intent of this Ordinance.

SECTION 4. That this Ordinance shall be in full force and effect from and after the date of its passage and adoption, and approval by the Mayor.
